Redemption of Euro-Denominated Senior Notes

Tokyo, April 24, 2024 --- MUFG today announced that it has decided to redeem its Series 23 EUR 1,000,000,000 2.264% Fixed to Floating Callable Senior Notes due 2025 (the “Notes”) in full in accordance with their terms on June 14, 2024, as stated below.

1. Security to be redeemed

Mitsubishi UFJ Financial Group, Inc. Series 23 EUR 1,000,000,000 2.264% Fixed to Floating Callable Senior Notes due 2025

2. Redemption date

June 14, 2024

No interest shall accrue on and after the redemption date.

3. Redemption price

EUR 1,000 per EUR 1,000 principal amount of the Notes plus accrued and unpaid interest from the last interest payment date applicable to the Notes up to, but not including, the redemption date.

This press release does not constitute a formal notice of redemption with respect to the Notes. A formal notice of redemption of the Notes will be provided in accordance with the terms of the Notes.
